Free Civil Legal Services to Help Families Impacted by the Opioid Epidemic

The Center for Arkansas Legal Services (CALS) and Legal Aid of Arkansas have received a combined \$2 million in grant awards from the Health Resources and Services Administration to provide free legal services to families impacted by the opioid epidemic.

CALS and Legal Aid will launch 'Beyond Opioids – Breaking Legal Barriers for Families in Recovery', an initiative focused on the wide range of legal issues that can hinder a person's recovery. Beyond Opioids connects impacted individuals and families from rural areas with a free civil legal aid attorney. "This completes the loop for a holistic approach to client services by providing vital, statewide access to justice for individuals and families in recovery," said Lee Richardson, executive director for Legal Aid of Arkansas. The three-year project started on September 1 and will be providing direct legal services to the target population by the end of 2020.

At the heart of 'Beyond Opioids' is a statewide referral system composed of a network of community partners that provide treatment, recovery services, and prevention services. "The opioid patients that we treat, and opioid use disorder patients across the state, many of them have legal entanglements and would benefit greatly from the Center for Arkansas Legal Services and Legal Aid's assistance," said Dr. Michael J. Mancino, program director for the Center for Addiction Services and Treatment and professor at UAMS.

Project partners come from health, law enforcement, education, and state agencies. "Individuals recently released from prison face a number of hurdles to successfully reenter society, including legal matters. Having a resource to refer the individuals to, under ACC supervision, for free legal assistance will be a great benefit to both the individuals and society as a whole," said Amber Schubert, general counsel, Arkansas Department of Corrections. This collaborative partnership addresses a justice gap by integrating legal support in Arkansas' prevention, treatment, and recovery strategy. "Connecting with our community partners is vital in reaching the individuals who need our assistance. These partnerships give Arkansans a chance for a successful progression from treatment, to recovery, to prevention, to helping reduce future substance abuse issues. Working with community partners is the key to fighting this

epidemic," said Jean Carter, executive director for the Center for Arkansas Legal Services.
